Mark Mobius, Ph.D., a renowned expert on emerging markets, is this year's Keynote Speaker for the 9th Pacific Region Investment Conference. Dr. Mobius is currently the Executive Chairman of Templeton Asset Management, LLC. In his current role, he directs the Templeton research team based in 15 emerging markets offices across the globe and manages several emerging markets portfolios for both retail and institutional investors. In 2006, Asiamoney magazine listed Dr. Mobius as one of the "Top 100 Most Powerful and Influential People," stating that he "boasts one of the highest profiles of any investor in the region and is regarded by many in the financial industry as one of the most successful emerging markets investors over the last 20 years. Dr. Mobius has written several books, including "Trading with China," "The Investor's Guide to Emerging Markets," "Mobius on Emerging Markets," "Equities—An Introduction to the Core Concepts," and "Mutual Funds—An Introduction to the Core Concepts." The World Bank and Organization for Economic Cooperation and Development appointed Dr. Mobius joint chairman of the Global Corporate Governance Forum Investor Responsibility Taskforce. He earned Bachelors and Masters Degrees from Boston University, and a Ph.D. in economics and political science from the Massachusetts Institute of Technology.
